## NEW STUDENT - TRANSFER INFORMATION FORM INSTRUCTIONS

The New Student - Transfer Information form was designed to assist the athletic director. Although the form cannot guarantee that the eligibility of all students new to your school can be immediately and unconditionally determined, it does provide a consistent method of information collection at the point and time of entry of each new student.

1. The form should be duplicated after typing your school name in the space provided under the dotted "Do not write below this line.
2. Provide a quantity of the forms to be included in the enrollment material to be completed when the student enrolls (guidance office, principal's office, assistant principal's office).
3. Don't ask or expect the enrolling office to evaluate the form or determine eligibility.
4. Request that the form be submitted as soon as possible after enrollment, to the athletic director for his/her evaluation. (It may be your choice that the student and parent meet with you as a matter of routine.)
5. The information above the bold line is intended to provide evidence to address Regulation 1, Section 2, Section 4, Section 7 and Section 9(A) (1) and (2).
6. Line 1: Indicates public, private or parochial school.
7. Line 2/3: Regulation 1, Section 9(A) (1) verification.
8. Line 4: Determine grade level.
9. Line 5: Regulation III, Section 2 (Interpretation).
10. Line 6: Verification of line 1 of form.
11. Line 7: Regulation 1, Section 9(A), (3).
12. Line 8: Regulation 1, Section 9(A), (4). J-1 VISA usually (not always) provides eligibility. The F-1 VISA is not issued to exchange students.
13. Line 9: Regulation 1, Section 9(A), (5).
14. Line 10: Regulation 1, Section 9(A), (6).
15. Line 11: Regulation 1, Section 9(A), (8).
16. Line 12: Regulation 1, Section 2.
17. Line 13: Regulation 1, Section 9(A), (13).
18. Line 14: Regulation 1, Section 9(A), (12).
19. Line 15: Regulation 1, Section 9(B)
20. Line 16: Regulation 1, Section 9 (C)
21. Line 17: Acknowledges student need to discuss the matter of eligibility because of confusion, extenuating circumstances or confidentiality.

The athletic director or principal is encouraged to evaluate the information provided by the student and determine eligibility by checking one of the five choices.

You may wish to copy this form for the student while keeping the original in the student's file for reference. There is no reason to send the form to the MHSAA, so please don't. However, if you are unsure about the student's eligibility, you are urged to contact the MHSAA for assistance.

For best results, establish a routine and be consistent in gathering and evaluating the information.
